PRIOR INFORMATION NOTICE

Notice for companies interested in participating in the selection procedure for the construction and furnishing of the Italian Pavilion at the 18th China International Machine Tool Show CIMT, April 10 – 15, 2023

ITA - Italian Trade Agency is the Governmental agency that supports the business development of Italian companies abroad and promotes the attraction of foreign investment in Italy.

With a motivated and modern organization and a widespread network of overseas offices, ITA provides information, assistance, consulting, promotion and training to Italian small and medium-sized businesses. Using the most modern multi-channel promotion and communication tools, it acts to assert the excellence of Made in Italy in the world. ITA is headquartered in Rome and operates through a network of offices worldwide linked to Italian Embassies and Consulates and it works closely with local authorities and businesses.

ITA operates in China through its offices in Beijing, Shanghai, Guangzhou and Hong Kong. A Desk is about to be opened in Chengdu. The Beijing Office is also in charge of Mongolia.

ITA Beijing is managing the participation of a group of Italian companies in the 18th China International Machine Tools Show (CIMT), which will take place at the China International Exhibition Centre (Shunyi Hall), through the realization of an Italian pavilion.

The Italian pavilion will host 26 Italian companies of the machine tools sector, that will showcase their latest machine tool technologies and products.

ITA Beijing is launching a tender procedure to appoint a company specialized in exhibition layouts for the provision of the complete setup and furnishing of the pavilion in all its parts (flooring, structures, walls, graphics, systems, facilities, furniture), according to the methods and conditions provided by a specific project and technical procurement contract.

The aim of the service consists in building a state-of-the-art exhibition pavilion with high quality materials that best represents the spirit of the Italian industrial culture as well as provide efficient tailored procurement and graphic services to the participating companies.

The bidding base amount will be **RMB 1.100.000,00, including all taxes and duties.**

Interested companies that meet the requirements at the date of this notice, should notify their interest by email to: pechino@ice.it

The expression of interest should be signed by the legal representative of the company or by an attorney with signature authorization and should indicate the following information:

- name of the company and legal status
- legal address (complete address)
- telephone, email address
- name of the legal representative or delegate, if any
- mail address for official communications

The deadline for the expression of interest is **Monday, 30th January 2023 at 16:00**.

Companies that submit their expression of interest will receive the complete tender package (Invitation letter, Pavilion project, Technical descriptions, Floorplans, Technical request summaries from participating companies, Contract conditions, CIMT 2023 Exhibitor manual) with instructions on how to participate to the tender.

The tender will be conducted during the months of February and March. Final public session for the appointment of the awarded bidder is estimated to be held by mid-March 2023.

The tender procedure may be interrupted or cancelled at any moment and for any reason, including cases of force majeure, by the Italian Trade Agency at its full discretion without generating any moral or legal commitment towards the candidates including those fully meeting the requirements.
